



## SWEEPSTAKES OPERATIONS CASH FLOW

1. Investor purchases a specific number of Sweepstakes Machines
  - As a Passive Investor earning 18% to 60% annual ROI paid monthly based on the total funds invested.

  - As an Owner /Operator Investor earning 25% to 35% ROI paid monthly based on the total number of Sweepstakes Machines purchased and/or housed.
